Organizational Context
<p>The <b>European Centre for Electoral Support (ECES)</b> is a non-profit private foundation headquartered in Brussels a global remit. ECES promotes sustainable democratic development through the provision of advisory services and operational support in favor of <b>all electoral stakeholders</b>, including electoral management bodies, civil society organizations dealing with civic &amp; voter education and election observation, political parties and parliaments dealing with electoral reforms, media, security forces and legal institutions dealing to electoral dispute resolutions. Since February 2012, ECES has signed <b>over 60 contracts</b> in support of transparent, credible and cost-effective electoral processes and the strengthening of democratic institutions <b>in more than 35 countries mainly, but not only, in Africa and Middle East</b>. In addition to that, the founders and personnel of ECES have acquired extensive field experience and, taken together, ECES can count on a specific knowledge and a well-established network in <b>over 70 countries</b> around the world. <b>The EU is by far the largest ECES' donor</b>, however the organization has also signed contracts and partnered with many other organisations.</p>
Project's context
<p>ECES has been officially awarded by the Delegation of the European Union (EU) to Jordan the contract for the implementation of the project "Enhanced Support to Democratic Governance in Jordan". ECES is the leader of the consortium of European not for profit organisations that will implement this project for the next 4 years. The other organisations members of the consortium are: the European Partnership for Democracy -EPD (<a href="http://www.epd.eu">www.epd.eu</a>), the French Media Cooperation Agency-CFI (<a href="http://www.cfi.fr/en">www.cfi.fr/en</a>); Netherlands Institute for Multiparty Democracy – NIMD (<a href="http://www.nimd.org">www.nimd.org</a>) and Westminster Foundation for Democracy (<a href="http://www.wfd.org">www.wfd.org</a>).</p> <p>The project "<b>Enhanced Support to Democratic Governance in Jordan</b>" aims to support reform process in Jordan, by consolidating democracy and promoting inclusiveness of national policy and decision-making process. This 4-years project will support democratization stakeholders in the reform process including: the House of Representatives; the Independent Electoral Commission and the Judiciary; Political Parties; the Ministry of Political and Parliamentary Affairs (MoPPA); Women and Youth; and Media and Journalists. The project's methodology rests on three core pillars in order to weld together a coordinated and coherent response: <b>1) Parliamentary support; 2) Electoral assistance; 3) Support to political party system</b>. The overall objectives of the project are: an increased political awareness amongst the Jordan population, especially amongst women and youth; Intensified efforts amongst elected institutions in public outreach for more inclusive decision making processes; and also improved service delivery by public demands. The project will be implemented along the lines of the European Response to Electoral Cycle Support Strategy (EURECS), conceived jointly by ECES and the members of the European Partnership for Democracy of which WFD is part. EURECS is an innovative delivery mechanism to implement electoral and democracy assistance activities that are consistent with European values and EU policies. EURECS adopts an inclusive approach towards a wide range of electoral stakeholders in order to ensure comprehensive and sustainable actions and it is built to help prevent, mitigate and manage electoral related conflicts.</p>

A Project Management Unit (PMU) will be established in Jordan to support the implementation of all project activities under the leadership of the Project Director and will be composed of representatives of the 3 project's components. WFD will lead on provision of support to the larger component in support of the House of Representatives (component 1) in a wide range of areas, utilising advice and mentoring provided by experienced technical advisors.

### **Functions / Key Results Expected**

Under the daily guidance of the Project Director and ECES HQ focal point appointed by the Executive Director, the Logistics and Operations Officer will have the following specific responsibilities and will provide the following deliverables:

- Closely liaise with ECES HQ for ensuring coordination and follow up of project activities;
- Prepare logistics and support plans, deployment timelines and budget requirements, Develop and implement methodologies and tools to enable effective execution of logistic plans;
- Manages logistics operations including management of logistics assets, materiel, contracts and personnel. Ensure timely, accountable and cost-effective delivery;
- Ensure that supervised staff are adequately trained, cross trained; identifies additional training needs to achieve high working standards;
- Prepare contingency plans and logistics preparedness reviews;
- Coordinate and ensure strategic logistics support;
- Coordinate logistics activities with the rest of the staff. Follows up on legal and financial aspects of the project, Implements logistics support policy, procedures and methodologies;
- Prepare reports on personnel and materiel movements and other operational logistics issues;
- Identify plans and manages special logistics operations;
- Ensure that accurate and complete accounting, reporting and internal control systems are functioning and that all relevant records are maintained;
- Attend and/or contribute to meetings with projects partners/stakeholders, to project's events etc;
- Identify and implement public relations and provide support for advocacy, monitoring and evaluation;
- Support the Project Director on demand and implement all required working tasks;
